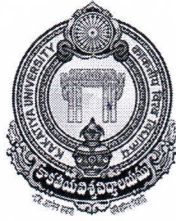

Vide KU letter cited at reference-1, the Dean Faculty of Education noted that due to change in B.Ed program pattern from year-wise to semester scheme, some of the B.Ed, students under year-wise course were not able to complete the course within the stipulated program duration. Accordingly, vide this office letter cited at reference-2, B.Ed. colleges under Kakatiya University were directed to conduct classes and such students were permitted to appear in Supplementary examination in 2015. Subsequently, similar permission was also given in 2016 and 2017.

In furtherance to the above, on the recommendations made by the Dean, Faculty of Education, vide reference-2, the Vice-Chancellor, in anticipation of the approval of the Standing Committee of Academic Senate, permitted the B.Ed. students of one-year course to appear for examinations in April/May 2018. As the university has earlier given similar permission twice, the permission given now will be 'Last and Final' opportunity. Accordingly, the principals of B.Ed. colleges under the jurisdiction of Kakatiya University are hereby informed to initiate necessary communications to inform all the B.Ed. failed students of one-year course, of their college, to make use of this last and final permission.
