The Vice Chancellor, Kakatiya University, in pursuance of the Gazette Publication (ref.1 enclosed) and the directions of the University Grants Commission (UGC), in anticipation of the approval of the Standing Committee of Academic Senate, agreed to adopt the University Grants Commission (Promotion of Academic Integrity and Prevention of Plagiarism in Higher Educational Institutions) Regulations, 2018.

All the Heads of Departments (HODs) of the University Departments and the heads of Research Institutes under Kakatiya University are hereby required to enforce the regulations from November 1, 2018, in accordance with the set guidelines (Gazette Enclosed). Accordingly, a 'Departmental Academic Integrity Panel (DAIP) is to be formed (See No. 10 in Gazette), and the same be sent to the Registrar, KU on or before **October 15, 2018**.

All the HODs are further directed to ensure that all the research work (PhD thesis, Student Projects, Articles to be Published in the Journals etc) of students, faculty, and staff, before submission are supported with Plagiarism Report **w.e.f. November 1, 2018**. Subsequently a soft copy of the same is submitted to INFILBNET within 30-days. The Plagiarism Checking software (URKUND) is available for free of cost in the Department of Library and Information Sciences, KU.
