In the Ref.1<sup>st</sup> cited, the State Convenor, Vidyarthi Jana Samithi (VJS),  
Hyderabad has requested to fill the Management Quota (B-Category) seats through  
online in Engineering Colleges, so as to do justice to the eligible poor students.  
Further, it is alleged that the Managements of the Professional Colleges have not  
given opportunity to the merit students of JEE mains and started admissions before  
announcement of the EAMCET results and collected donations without following the  
rules and regulations. Therefore, it is requested to issue instructions to the  
Managements of the Professional Colleges to process the admissions after the  
announcement of EAMCET Results.

In this connection, it is to reiterate that the State Government have issued  
orders in G.O.2<sup>nd</sup> cited, prescribing the admission procedure to fill up Category- B  
Seats (30%) for adherence by the Managements of the Professional Colleges,  
failing which the Institutions will attract penalty for violation of the rules, as laid  
down in the G.O.2<sup>nd</sup> cited.

In the circumstances, the Managements of the Professional Colleges  
(Engineering / Pharmacy/ Architecture / MBA & MCA Colleges) in the State are  
hereby informed to adhere to the Guidelines issued in G.O. 2<sup>nd</sup> cited, while filling up  
Category- B Seats (30%) of the respective Colleges, failing which action will be  
initiated against the Institutions concerned in terms of the G.O.2<sup>nd</sup> cited.
