#### Sir/Madam

It has been brought to the notice of the undersigned that certain students of SC,ST, BC, EBC, Minority and PHC who passed their Under- Graduation / Post Graduation from the University/Constituent and affiliated (Govt./Aided/Unaided Private) Colleges under the jurisdiction of this University are facing hurdles in getting no dues and taking Transfer / Bonafide/ conduct / Migration Certificates due to non release of their scholarships from the respective welfare departments.

In this context, I am to inform you that as per the guidelines issued from the Welfare Departments and the Govt. of Telangana, the students who were sanctioned the scholarships against the tuition and other fee but not released by the respective Welfare Departments have to be considered to issue Transfer and other certificates subject to ascertaining the eligibility. Further, the Deputy Director (BCW), Hanumakonda while referring the letter under reference 5<sup>th</sup> cited issued instructions to all the Principals and Managements of the colleges to not to collect Tuition fee (RTF/Special Fee, not to hold certificates and Exam Hall Tickets of poor BC & EBC students who are eligible for Fee reimbursement, renewal as well as fresh students "Hard Copy Received by District Officer" without fail any deviation from the instruction of the Government will warrant action under CCA Rules.

As such, All the Principals/Managements of the colleges are hereby directed to implement the above guidelines scrupulously and instruct the officials concerned to issue Transfer and other Original Certificates to the passed out candidates of SC/ST/BC/EBC/PHC and Minority Communities who were eligible, applied and sanctioned the scholarships to the extent of prescribed tuition and other fee but not released by the respective Welfare departments accordingly.

However, the candidates who are ineligible and not sanctioned must be cleared their dues before issuing TC and other Certificates as per the norms.

I invite your kind attention to the reference cited, the Commissioner of BC Welfare Department T.S., Hyderabad has issued instruction that, the Colleges/ Managements and Principals, shall not to collect Tuition Fee (RTF) / Special FEE, not hold certificate and exam hall tickets of poor BC & EBC students who are eligible for Fee Reimbursement renewal as well as fresh students as per Government rules issued time to time, failing which necessary steps will be taken against the college Managements / Principals for blacklisting the concerned colleges from scholarships scheme.

Further, the Commissioner of BC Welfare, TS., Hyderabad noticed that certain colleges Managements / Principals are insisting the poor BC & EBC Students for payment of Tuition Fee (RTF) and not allowing them to write exams and also not issuing certificates to passed out students which is against Government rules. The Department will reimburse the Tuition fee to the Colleges / Managements concerned as per the eligibility.

In view of the, all the College Principals and Managements are directed to do not collect Tuition Fee (RTF) / Special FEE, not to hold certificates and exam hall tickets of poor BC & EBC students who are eligible for Fee Reimbursement renewal as well as fresh students "Hard Copy Received by District officer" without fail any deviation from the instruction of the Government will warrant action under C.C.A. Rules.

In the reference 1st cited, this office has directed to all the Deputy Director's/
District BC Development Officers in the state to issue instructions to all college
Managements/Principals in the District not to collect Tuition Fee/Special Fee, not
hold certificates and exam hall tickets of poor BC/EBC Students who are eligible
for Fee Reimbursement as per Government rules issued time to time, failing which
necessary steps will be taken against the College Managements/ Principals for
blacklisting the concerned colleges from scholarships scheme.

In the reference, 2<sup>nd</sup> cited the Government has instructed to issue a circular to the College authorities for issue of original certificates to the students who are eligible for RTF, without insisting for payment of full fee.

In view of the above copies of the references 1st & 2nd cited is here with enclosed and the DDs / DBCDOs in the State are once again instructed to follow the instructions and ensure that the Colleges Principals / Managements, do not collect fuition Fee from the eligible BC/EBC Students and also take necessary steps for issuing of study certificates, exam hall tickets to BC/EBC scholarships students without fail. Any deviation from the instructions of the Government will warrant action under C.C.A Rules.
