Sir/Madam,

I am to inform you that many of the students who could not pass certain papers, project work, viva-voce, seminars etc., of various courses within the time frame requested to accord one time permission to clear their back-logs in relaxation of time frame. it involves lot of expenditure in providing question paper and in evaluation process for the old students of various batches. All such requests were placed before the Standing Committee of the Academic Senate at its 2nd meeting held on 6th March 2023 for discussion and consideration.

The Vice-Chancellor in pursuance of the decision taken by the Standing Committee of the Academic Senate has accorded **one time permission as a last chance** to all the ex-candidates of UG & PG (Professional & Non-Professional) Courses in Year-wise/Semester-wise, CBCS/NON-CBCS patterns who studied entire course but have some back-logs such as theory, practical, Seminar, Viva-voce or project work and internal assessments etc. to clear their back-logs in one time in relaxation of time frame during the academic years 2022-2023 and 2023-2024 only subject to the following conditions:

1. The Candidates shall be permitted to clear their back-log papers subject to no technical issues either in conducting examination or in issuing certificates as per the then or existing syllabus. If any technical issue arise in any case, the University decision is final.
2. The Examination Branch shall provide the question paper in old scheme or in existing scheme as the case may be for all the ex-candidates applied to take their exams along with the regular/Supplementary examinations held for the courses during the years 2022-2023 and 2023-2024 .
3. All the ex candidates have to seek permission individually from the Registrar, Academic, KU by remitting required processing fee for all the theory, practical, Seminar, Viva-voce, Internals or project work etc., After getting permission have to pay the examination fee prescribed before submitting Nominal Roll to the Examination Branch.
4. The Candidates have to clear their back-logs appearing either in old syllabi or equivalent papers in the existing syllabi as ascertained by the Chairperson, Board of Studies in the discipline concerned.

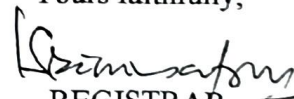
